SCE takes no responsibility for the internal controls of the customer's business after the loan has been signed.
	I understand and acknowledge that OBF is a loan program and requires repayment (It is not an incentive or rebate). Energy savings are estimated values, not guaranteed. Project changes may impact loan terms. Project scope changes are not permitted. Customer understands that OBF is a loan program billed on their monthly utility bill.
	Customers using the Site Specific Option for OBF understand that energy usage provided by the Trade Pro will determine their OBF loan repayment amount. If not accurately calculated, the inappropriate use of Site Specific Savings for loan calculation may result in an increase in your monthly utility bill.
	Existing equipment must be installed and in operating condition in order to qualify for incentives/rebates and OBF. The replacement of burnout or non-functional equipment is considered free ridership and makes the project ineligible for incentives, rebates, and, on-bill financing.
	Customer confirms that the OBF loan funds are required for the project to be completed, and that without the loan funds, the project would not otherwise proceed and be completed with the same scope or within the same timeframe.
	SCE does not recommend, endorse, qualify, guarantee or make any representations or warranties regarding the services, work, quality, financial stability or performance of any Trade Pro.
