On November, 15, 2010, SCE filed with the CPUC Application No. A.10-11-009 for a Test Year 2011 Water General Rate Case (GRC). The California Public Utilities Commission (CPUC) will hold evidentiary hearings (EHs) regarding SCE’s Application to increase water service rates on Catalina Island at the times and places listed below. The CPUC’s policy is to schedule hearings in locations that are accessible to everyone.

## **EVIDENTIARY HEARINGS**

The CPUC schedules evidentiary hearings (EHs) whereby the formal parties of record provide testimony and are subject to cross examination before the CPUC's assigned Administrative Law Judge (ALJ). The assigned Commissioner may be in attendance as well. These hearings are open to the public to listen, but only those who are formal parties of record are allowed to participate, and present testimony and oral arguments. The CPUC has their own court reporters who will take the comments of those formal parties of record participating in the EHs. Since SCE filed the Application, they will be providing testimony at the hearings. An additional formal party is the Division of Ratepayer Advocates (DRA) which consists of engineers, accountants, economists and attorneys who independently evaluate the proposals of utilities and present their analyses and recommendations for the CPUC at EHs. Once hearings are completed, the ALJ will consider all of the evidence presented and release the proposed draft decision. When the CPUC issues a final decision, it may adopt, amend, or modify all or part of the ALJ's draft decision. The final decision may differ from the proposed application filed by SCE.
