IN COMPLIANCE WITH D.20-04-004**

Southern California Edison Company (SCE) hereby submits its annual report on the Mobile Home Park (MHP) Utility Conversion Program, which was established to help convert mobilehome parks and manufactured housing communities from master-meter/submeter and master-meter/non-submeter service to direct utility service. SCE’s annual MHP report for the period of January 1, 2021 to December 31, 2021, attached hereto, provides a narrative program assessment (Appendix A), data in the MHP Annual Report Template (Attachment 1) and an updated list of all MHP conversions completed and those in progress, including their city and county, space count, gas utility and electric utility (Attachment 2).

In (D.)20-04-004 (the Decision), approved on April 16, 2020, the Commission authorized a permanent ten-year Mobilehome Park Utility Conversion Program.¹ This decision established new program eligibility requirements, a new prioritization list, and reporting requirements. MHPs that are currently in progress will be captured under the new reporting requirements.

Ordering Paragraph (OP) 10 of D.20-04-004 states that each electric and/or gas corporation shall annually prepare a report for the Mobilehome Park Utility Conversion Program, as follows: “(a) by February 1 of each year beginning in 2021, and continuing thereafter until the end of the program in 2030 utilizing the Revised Annual Report Template contained in the updated January 2020 Staff Evaluation [] and as modified by this decision. At the direction of the Commission’s Safety and Enforcement Division (SED), each utility shall file electronic copies of its Annual Report to the service list of this, or successor, proceeding. Utilities shall post copies of their Annual Report on their respective websites and the Commission’s SED shall do the same.”

In accordance with OP 12 of the Decision, SCE’s annual report was verified by an officer of SCE, and the parks completed and in progress list is filed in both confidential and redacted form. Additionally, SCE is providing a list of all the MHP conversions completed in 2021 and in progress within its territory, and is submitting a narrative program assessment along with the data requested in the MHP Annual Report Template.

SCE Mobile Home Park Utility Conversion Program Annual Report

(For the Period January 1 to December 31, 2021) in Compliance with D.20-04-004

1. Executive Summary

On April 16, 2020, the California Public Utilities Commission (CPUC) approved and authorized SCE to execute the Mobilehome Park Utility Conversion Program (MHP Program) through D.20-04-004 (the Decision). This is a ten-year program (2021-2031) for conversion from master-meter/submeter natural gas and/or electric service to direct service and is approved for mobilehome parks and manufactured housing communities (collectively, MHPs) located within the franchise areas of electric and/or natural gas corporations.

2. Background

On March 13, 2014, the CPUC approved and authorized SCE to execute the Mobilehome Park Utility Upgrade Program (Pilot Program) through D.14-03-021. The Pilot Program was a three-year pilot (2015-2017) to convert master-metered/sub-metered electric and gas services to direct utility services for qualified mobilehome parks and manufactured housing communities (collectively MHPs).

Resolution E-4878, issued on September 28, 2017, directed the utilities to continue to “complete all Category 1 MHP conversions as established in D.14-03-021 (approximately 10 percent of the MHP spaces) and work on Category 2 and 3 MHPs until the earlier date of December 31, 2019 or the issuance of a Commission Decision for the continuation, expansion or modification of the program.”²

Resolution E-4958, issued on March 14, 2019, directed the utilities to “continue their Mobile Home Park (MHP) Utility Upgrade Pilot Program until the earlier date of either December 31, 2021, or the issuance of a Commission Decision for the continuation, expansion or modification of the program beyond December 31, 2020 in R.18-04-018, subject to the limitations in OP 2.”³ OP 2 limits eligible MHPs to those for which the utilities and/or MHP owners have incurred financial obligations on or before November 1, 2018.⁴ It further limits the number of eligible spaces to 3.33 percent annually of the total master-metered spaces in a utility’s service territory, unless a single MHP upgrade would exceed the 3.33 percent limit, and sets prioritization criteria for MHP conversions.⁵

On July 1, 2021, the Commission’s Safety and Enforcement Division (SED) published the four-year MHP application prioritization lists. Under certain extenuating circumstances,

SED is allowed to adjust the prioritization list on an annual basis not to exceed 3 percent of the total spaces within a utility's Category 1 population.⁶

3. Program Implementation

The Pilot Program was planned to achieve the conversion, on a combined to-the-meter (TTM) and beyond-the-meter (BTM) basis, of 10 percent of the estimated MHP spaces in SCE's service territory, which represents approximately 10,800 spaces. Subsequently Resolution E-4878 authorized SCE to convert up to an additional 20 percent of the MHP spaces by December 31, 2019, or the issuance of a Commission Decision to continue, expand or modify the MHP Program.⁷

D.21-04-004 preserves the current MHP annual target conversion rate at 3.33 percent with a cumulative target of converting 50 percent of eligible MHP spaces by 2030 with a priority to maximize conversion of higher risk master-meter/submeter systems that supply natural gas to mobilehome parks or manufactured housing communities and where possible, dual conversions (natural gas and electric) are preferred. The Decision also expands s eligibility to include sub-metered and non-sub-metered mobilehomes.

Since inception of the Pilot Program, 84 parks have opted out and SCE has worked with the Commission to identify additional MHPs to participate in the Pilot and MHP Program. To reach the MHP Program's goal, SCE has developed a robust process to perform the MHP conversions and, where possible, dual conversions (natural gas and electric) have been planned through joint efforts with impacted gas service providers. Additionally, joint trenching opportunities were leveraged with the MHP's existing telecommunications provider(s).

4. Cost Assessment

From inception of the Pilot Program through December 31, 2021, SCE has converted 254 MHPs with a combined total of 16,580 spaces, including a space count true up in 2018 and 2019. The total conversion cost for these MHPs is \$245,155,748, resulting in a current average per-space cost of \$14,786. SCE considers an MHP to be “Converted” after System Cutover has occurred, master meter removed, and all financial obligations have been fulfilled. System cutover is defined as all residential spaces that have switched from the park owned legacy electrical system to a direct service SCE electrical system and legacy meter removed or transferred to common area only usage. Construction costs, TTM and BTM, incurred per space are detailed in the attached MHP Annual Report Data Template. Costs may vary depending on multiple factors, including availability of contractors, geographic location, etc.

TTM Costs include the portion paid by SCE for TTM activities, which are shared with other participating utilities where service territories overlap. These costs include trenching and paving, company labor in support of the program including to-the-meter work for selected MHPs, meter installation and master meter removal.

BTM Contractor Costs are reimbursed to the MHP owner/operator or paid to the BTM Contractor to perform the BTM construction work.

Decision states, “If Utilities do not expect to meet the above 2021 annual soft targets, they should justify in their annual reports beginning in February 2022.”⁸ met its soft target of \$53 M primarily due to the ramp down requirements outlined in Resolution E-4958, OP 2 and the ramp up activities for the approved projects published on the new priority list issued by SED in July 2021. Resolution E-4958 OP 2 limited the eligible MHPs that could be converted in the following years . This transition period created a gap in executable work between 2020 and 2021. Additionally, SCE conducted a TTM contractor Request for Proposal (RFP) late fourth quarter of 2020, finalized on March 31, 2021, which also contributed to a 3-month delay in the first quarter 2021 construction starts. starts.

5. Program Assessment

The initial purpose of implementing the Pilot Program was to conduct a pilot during which the investor-owned utilities (IOUs) and the Commission could assess the feasibility and effectiveness of a mobilehome park conversion program as outlined in the OPs of D.14-03-021. SCE considers its Pilot Program a success due to the achievement of the following performance indicators listed below and will maintain the use of the same indicators to continue to define success for the 10-year program.

- **Program Participation**

The Pilot Program began on May 22, 2015, when SCE received a list of selected MHPs from the CPUC's SED. Since that time, SCE has successfully partnered with MHP Owners/Operators to increase participation. From inception of the Pilot Program through December 31, 2021, SCE has successfully converted⁹ approximately 16 percent of eligible mobilehome spaces in SCE's service territory (including MHPs converted under both the Pilot and MHP Program).

- **Safety Performance**

In 2021, SCE has maintained a high safety standard with zero (0) reportable TTM contractor incident(s) and zero SCE employee incident(s).

- **Improved Safety and Reliability of MHP Electric Distribution Systems**

MHPs that participated in the program were provided a newly installed distribution system in compliance with current standards of all utility specifications and requirements. This system will provide safer and more reliable service to the MHP residents.

- **Increased Access and Availability to SCE Customer Programs and Services**

Upon conversion of the MHP, residents have immediate access to SCE income-qualified and/or discount customer programs and services, such as California Alternate Rates for Energy (CARE), and Medical Baseline. Residents can also take advantage of time-of-use rates and/or energy efficiency rebates, which can help them save energy and money on their electric bills. Additionally, customers can contact SCE's customer service representatives with billing inquiries or to ask questions regarding other aspects of their utility service. MHP residents can also access SCE's online tools and services to monitor their energy usage directly and discover additional ways to save energy and money.

From January 1, 2021 to December 31, 2021, 547 MHP residents of parks selected for utility upgrade were enrolled in SCE's CARE and FERA programs and 3 were enrolled in SCE's Medical Baseline program.
