1. Do any regulated or sensitive environmental resources (e.g., plant/animal species, cultural/paleontological resources, waters/wetlands, state scenic highways, etc.) occur at or near the site? If yes, please use the space below to provide a description.

Examples: Native American lands.
Coastal California gnatcatcher (federally threatened species) is known to occupy the vegetation by the site.
A dry creek runs through the site.
Artifacts have been found during construction at the site.

2. Current environmental guidance recommends locating Charge Ready infrastructure 50 feet away from UST and supporting piping and dispenser locations.
